Subject: MAY VICE CAPTAIN'S REPORT

Without their efforts, we could not have gotten through this course.
- 2. Getting OSC examinations seem to be a problem in this District. I had ordered 18 Part A exams and received 9 and 18 Part B exams and received 2. I have spoken to a few Division Captains and I was informed that they have had the same problem. I am in the process of writing a letter to the Director, via the chain of command, about this problem
- 3. The Division's Operations Workshop was held on Thursday, 25 April. A second Division workshop is a possibility. - 14. Vessel Facility Inspection: Note when submitting your Facility paperwork, please use your new member number. Also, include on the top of the paper your Unit number (i.e. 014-18-01). This will make the process much smoother. Also, all Vessel Examiners should use their new member number and include their Unit number. All Vessel Facility Inspection paperwork should be submitted to Yvonne Bangston, SO-IS.
